SCHOTT DISCLAIMS AND EXCLUDES ALL OTHER EXPRESS ORAL OR WRITTEN WARRANTIES AND ALL WARRANTIES IMPLIED BY LAW WITH RESPECT TO THE PRODUCT, INCLUDING WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT OF THIRD PARTY RIGHTS, WHETHER OR NOT SCHOTT IS AWARE OF THE INTENDED USE OF THE PRODUCT AND WHETHER OR NOT THE PRODUCT IS USED ALONE OR IN COMBINATION WITH ANY OTHER MATERIAL OR EQUIPMENT. No warranty claim is valid under this warranty unless the warranty claim is made within thirty (30) days of the date of purchase.

#### PYRAN® Platinum F Glass-Ceramic Limited 3-Year Warranty

SCHOTT North America, Inc. ("SCHOTT") warrants that, at the time of purchase from SCHOTT, the PYRAN® Platinum F glassceramic (the "Product") will conform to SCHOTT's then current Product specifications. SCHOTT North America, Inc. ("SCHOTT") warrants that, at the time of purchase from SCHOTT, the PYRAN<sup>®</sup> Platinum L glass-ceramic (the "Product") will conform to SCHOTT's current Product specifications applicable to the Product at the time of purchase.
